Perry County Subdivision and Land Development

1. COUNTY FEES FOR COUNTY SUBDIVISION/LAND DEVELOPMENT APPLICATIONS

- WHERE THE APPLICATION IS REGULATED BY THE PERRY COUNTY SUBDIVISION AND LAND DEVELOPMENT ORDINANCE

This fee should be utilized when a subdivision and land development is proposed within a municipality where Perry County has jurisdictional authority under the Perry County Subdivision and Land Development Ordinance. (The eight (8) municipalities where this fee is applied are: *Blain Borough, Jackson Township, Landisburg Borough, Millerstown Borough, New Buffalo Borough, Northeast Madison Township, Southwest Madison Township, and Toboyne Township*) IF YOUR MUNICIPALITY IS NOT IN THIS LIST YOU ARE REFERRED TO FEE SCHEDULE 2. BELOW.

- Subdivisions - \$90.00 base fee, plus \$5.00 for each lot.
- Land Development (Residential) - \$90.00 base fee, plus \$5.00 for each dwelling unit proposed.
- Land Development (Non-residential) - \$90.00 base fee, plus \$5.00 for each acre of land proposed to be disturbed during site construction.

(Engineering review fees may also be incurred to cover all County expenses associated with the use of the County Engineer to assist in the review process.)

2. COUNTY FEES FOR MUNICIPAL SUBDIVISION/LAND DEVELOPMENT APPLICATIONS

- WHERE THE LOCAL MUNICIPALITY HAS ENACTED A SUBDIVISION AND LAND DEVELOPMENT ORDINANCE TO REGULATE THE APPLICATION

This fee applies when Boroughs or Townships have enacted a local Subdivision and Land Development Ordinance. (Of the County's thirty municipalities, this fee applies to the twenty-two (22) municipalities not listed under 1. above.)

- Subdivisions - \$70.00 base fee, plus \$5.00 for each lot.
- Land Development (Residential) - \$70.00 base fee, plus \$5.00 for each dwelling unit proposed.
- Land Development (Non-residential) - \$70.00 base fee, plus \$5.00 for each acre of land proposed to be disturbed during site construction.

Effective Date: May 17, 2007 (The fees listed above will apply to all applications submitted on or after this date.)
