## INTRODUCTION . . .

The Tri-County Regional Planning Commission's 2020 Building Activity Report shows Dauphin and Perry counties continued to experience a growth in building value over the previous year, with only slight differences in most of the activity sectors despite the COVID-19 pandemic.

## **RESIDENTIAL**

In residential development, Dauphin County's municipalities issued permits for 716 new residential units in 2020, a slight decrease from the 723 permits issued in 2019. Conversely, Perry County experienced a notable increase, with 105 permits in 2020 compared to 76 permits in 2019.

The area's residential growth continues to occur primarily in the first-ring suburbs with smaller, infill development, matching the national trend in which residents prefer living on smaller lots closer to amenities and services. Lower Paxton Township was the municipality with the largest increase in new housing permits at 382, accounting for 53 percent of Dauphin County's total.

## **COMMERCIAL**

The region's new commercial development dropped in 2020, which was not unexpected due to economic uncertainty over the pandemic. Between the two counties, 39 permits for new commercial facilities were issued -- 38 in Dauphin and one in Perry -- down from 56 in 2019. Despite the decrease in permits, the value of new commercial development in Dauphin County jumped from \$58.2 million in 2019 to \$94 million in 2020.

The number of commercial improvements and expansions also declined, from 592 permits in 2019 to 371 in 2020. (Perry County issued two of these permits in 2020, with the rest coming from Dauphin County.) The value of these projects increased, however, from \$112.5 million in 2019 to \$113.8 million in 2020.

## **INDUSTRIAL**

Perry County again had no industrial activity. Dauphin County's permits for industrial improvements and expansions dropped from 28 in 2019 to 18 in 2020. The value of these permits went up sightly, however, from \$6.6 million in 2019 to \$6.8 million in 2020.

The number of new industrial establishments held steady from 2019 to 2020 at three permits. The value for these also remained close, with \$8.3 million in 2020 compared to \$8.4 million in 2019.

Overall, despite the effects of the pandemic, the figures in this report demonstrate a continued pattern of building the local tax-base and providing new job opportunities.

If the inner-ring suburbs continue to grow, it will be crucial to link the region's transportation options with our land use regulations to ensure that the built environment we desire is achieved and accessible to all, as recommended in TCRPC's Regional Growth Management Plan.


