FOREWORD

This consolidated 2017 Regional Building Activity Report from the Tri-County Regional Planning Commission focuses on building permit activity for residential, commercial and industrial development, providing an analytical tool for the area and meeting the objectives of TCRPC's Regional Growth Management Plan.

It should be noted that at the end of 2015, Cumberland County discontinued its affiliation with TCRPC's regional planning program but remains part of the transportation planning program and the Harrisburg Area Transportation Study. Therefore, any depiction or reference to Cumberland County in the 2017 Regional Building Activity Report should not be interpreted as any type of association with or support for TCRPC's regional planning program, but rather represents the inseparable connection between transportation planning and land use planning. In order to include Cumberland County fully in the regional transportation planning program, it must also be considered in TCRPC's regional land use planning efforts and included in its assessment of building permit activity in the region.



INTRODUCTION

The Tri-County Regional Planning Commission's 2017 Building Activity Report shows that there was a slight decline in residential and commercial activity in the region since 2016 but an increase in industrial permits, both in number and value.

The region had 1,667 new residential units in 2017, down from 1,780 units constructed in 2016. Dwelling units in Perry County, however, increased 35 percent in 2017, with a rise in single family home permits (92).

As in previous years, the area's residential growth is mostly happening in the first-ring suburbs with smaller infill development. This continues to reflect the national trend of residents preferring to live on smaller lots that are close to amenities and services.

New commercial development also dropped in 2017. Across the region, 113 permits for new commercial facilities were issued in 2017, compared to 132 in 2016. However, the value of commercial sector improvements and expansions was mixed. In Dauphin County, permit value rose from \$78.3 million in 2016 to \$132.3 million in 2017, a 69 percent increase.

In the industrial sector, there was an increase in both new, improvement and expansion permits. There was also a corresponding increase in the value of permits in their respective categories.

Overall, the figures in this report demonstrate a continued pattern of building the local tax-base and providing new job opportunities. If the inner-ring suburbs continue to grow out, it will be crucial to link the region's transportation options with land use regulations to ensure our desired built environment is achieved and is accessible to all, as recommended in TCRPC's Regional Growth Management Plan.
