

**If you could instantaneously make one change (big or small) to the transportation system in HATS region without concern for cost or other potential obstacles, what would it be?**

**Complete Answers.**

**COMMENT #1**

Better tailor our roadways to match the demands of all modes and incorporate traffic calming where possible. We have many facilities that are oversized (too many vehicle lanes, wider than necessary lanes, etc. , leading to high speeds and unsafe driving practices.

**COMMENT #2**

A bridge is needed in northern Dauphin County across the Susquehanna River. It should be located south of Millersburg in Upper Paxton Township and follow the current utility line. There is a drastic need for better connectivity in this part of the region, for safety, emergency response, commerce and economic development.

**COMMENT #3**

make website user-friendly.

**COMMENT #4**

Widen I-81 to 3 lanes (or make similar improvements) through its length in Cumberland County.

**COMMENT #5**

Some sort of regional trolley/rail or tracked transportation to link up all the little towns surrounding Harrisburg. Also replace the company managing Harrisburg Parking System, they are terrible and not even from PA.

**COMMENT #6**

An extensive and comprehensive light-rail and commuter rail network

**COMMENT #7**

More transit and transit information available to elderly who may not have computer access - I have an elderly (80s) neighbor who still drives and regularly gets into car accidents (I find out after the fact) - she has no cellphone or internet access and I can see transit is increasing, but I know my neighbor isn't the only one in this situation. Flyers with schedules and phone numbers to call at the local supermarket (Weis) or the library could be helpful for elderly, especially if there are direct routes to grocery stores.

**COMMENT #8**

Big change (and I know on the state level not something HATS can undertake independently) make those who use the roads more responsible for paying for their upkeep - ie tolls or higher gas tax. strong believer in user taxes. Small change - develop an integrated traffic signal system throughout the region. Also need funding for local municipalities to maintain and support them.

**COMMENT #9**

Add a light rail system linking Carlisle, Harrisburg and Hershey and the communities along that route. This could've already been up and running, but Cumberland County is full of NIMBYs and short-sighted commissioners.

**COMMENT #10**

Cumberland, Perry & Dauphin counties need train/transit systems that feed into Harrisburg as the hub!

**COMMENT #11**

Increase the availability and convenience of public transportation to communities around Harrisburg and other cities. Connected bike routes, and safe routes to schools to encourage non-motorized student transportation to schools.

Improving our transit system to make it more accessible and timely so more folks could utilize it as a resource. Though beyond our HATS region, improvements to regional rail from HBG to PGH and to DC/BAL would be optimal.

As a means to achieve this I would like to see minimum parking mandates eliminated or flipped to become maximum parking mandates, considerable traffic calming measures installed on arterial roads through populated areas, and money spend on infrastructure improvement to prioritize making walking, cycling, and public transit safer and a more convenient option than driving/parking a car.

**COMMENT #29**

Bring back the trolleys and light rail including a penn stater for games that stops at the stadium and has tailgate trains

**COMMENT #70**

Provide additional capacity on interstate and arterial roadways to reduce congestion and improve safety.

**COMMENT #71**

I 81 should be 3 lanes each way between I-76 and I-78

**COMMENT #72**

Increasing capacity of the Transportation system. Our region is one of the fastest growing in the state based on population. More and more housing are being developed along with continued expansion of distribution centers which increases the heavy truck traffic in our area. Our roads and bridges need to be updated and upgraded to keep up with the continued growth in our region.

**COMMENT #73**

Separate Interstate System (I-81 & I-83) entirely from Rt 581 and the rest of our local transportation network.

Reduce the number of potholes and uneven surfaces that damage cars.

**COMMENT #82**

Maintain existing transportation system to the maximum level as possible.

**COMMENT #83**

A public transit system with a mix of modes (light rail, subway, bus, tram, etc.) with high frequency (every 7 minutes or less) that runs at least 18 hours a day 7 days a week. A system that could truly replace car ownership.

**COMMENT #84**

Dependable, fast and efficient public transportation between Carlisle and Harrisburg both for office workers travelling to downtown Harrisburg for work and shift workers travelling to Carlisle area warehouses for work. The daily bus from Carlisle to Harrisburg should NOT take an hour, and there need to be more frequent and convenient options to help shift workers get to area warehouses.

The availability of affordable housing in Cumberland County has hit a crisis point, and many low income workers are being priced out of the market and forced to move to Dauphin, Adams or Perry county in order to find housing that they can afford. If they do not have a car, they therefore are no longer able to maintain employment at Carlisle warehouses.

**COMMENT #85**

Create a transportation system that actually makes sense. Years ago, when I tried to use the bus system to get from uptown Harrisburg to just across the river to the east side of Camp Hill, it was going to take me 1.5 hours to take the bus, transfer to a different bus and go across the river. And heaven forbid one of my connecting busses was delayed, then my trip would take twice as long. To drive the same distance took me 15 minutes. I didn't mind taking my commute from 15 to 30 minutes if it meant helping the environment, but an hour and a half for a 15 minute drive? That didn't make any sense. Also, trying to figure out the bus routes, costs and guidelines for simply crossing from one county to another was mind boggling. It didn't make any sense. I've traveled in other cities that make it very simple. They had apps and systems on the computer where you could plug in where you started and where you wanted to go and it told you which routes to take along with time tables. It was VERY user friendly. I feel if we made the systems more user friendly for new users, and make the transit systems makes sense to use them, you would get more people to use the mass transit systems out there.

**COMMENT #86**

Require site (both commercial and residential) developers to make road improvements to account for increased traffic due to their project.

**COMMENT #87**

Better planning for the I-81 Corridor from Maryland to I-78. The warehouse boom is not consistent with the I-81 transportation system, land use resulting in many heavy truck traffic, congestion, and traffic accidents

**COMMENT #88**

Add another bridge crossing of the Susquehanna River

**COMMENT #133**

Roadway lighting installed during LED streetlight conversion programs would adhere to the Illuminating Engineering Society's Five Principles of Responsible Outdoor Lighting. Particularly, by

1. Using warmer color lights where possible to limit the amount of shorter wavelength (blue-violet) light to the least amount needed. In residential districts, use LEDs having a color temperature of no more than 2700K, and lower if possible, and no more than 3000K in other districts.
2. Minimizing glare and light trespass from street lights by using house-side shields to keep direct illumination off of the windows and doors of residential uses.

3. Roadway luminaires would have a BUG Rating of B1-U0-G1, and if possible, a B0 rating. While it's not possible to eliminate glare, it should be minimized to avoid harm to the quality of life in the community being illuminated.

**COMMENT #134**

Have (tractor trailer) trucks use their own segregated lane on Interstates

**COMMENT #135**

Enhancing bike/ped connectivity within the region.

Turn more car lanes into bike lanes

**COMMENT #137**

Make sure all users are paying their fair share towards systems they utilize

**COMMENT #150**

Additional bike paths and safer bike routes.

**COMMENT #151**

Make public transportation available to all residents (rural, suburban, urban) without limitations to time, mode of transportation, or cost.

Widen I-81 to 3 lanes from Carlisle to Wertzville Road and PA 581 to 3 lanes from I-81 to I-83. This would solve both congestion and safety issues.

**COMMENT #153**

Get a light rail line to downtown Harrisburg so that we don't have to take the congested highways in.

**COMMENT #154**

Offer regular, fast, electrified, and reliable Public Transit between boroughs in Cumberland County and Harrisburg. That would run on nights and weekends.

**COMMENT #155**

Upgrade all traffic signals to the latest technology to move vehicles as efficiently as possible as possible.

**COMMENT #156**

Light rail system, or trolley line, similar to what was in the area in the past. As having a system to transit in the area would be great for commuting. Along with building/ revitalizing areas by placing a platform.
